



## PERSONAL DATA PROCESSING INFORMATION AND CONSENT TO PERSONAL DATA PROCESSING

In accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (hereinafter referred to as the Regulation) a member of a regional association (hereinafter RA) is informed that in connection with his / her membership in the RA (hereinafter referred to as the "Administrator"), he / she is obliged, pursuant to §3a, paragraph 3, of Act No. 115/2001 Coll. on the promotion of sport (hereinafter "APOS") to process all the personal data in the application form.

All personal data are processed for the purpose of keeping a membership base and associated activities (eg, applications for subsidies, insurance, etc.).

The RA member is informed that pursuant to §3a, paragraph 6 of the APOS, Personal Data according to points 1 to 4 will be processed and stored for a period of 10 years from the date when he/she ceases to perform the activity for which he/she is registered by the Administrator.

He/she is informed that, based on the legitimate interest of the Administrator, Personal Data will be processed and maintained for the purpose of keeping the membership base and related activities for 10 years from the date when he/she ceases to perform the activity for which he/she is registered by the Administrator.

He/she acknowledges that the Administrator passes through AMF ČR / BSMK personal data to these Processors:

- competent authorities of state administration and self-government, in order to:
- applications for subsidies under §6b of the APOS.

He/she is informed that, if he/she refuses to provide the mandatory Personal Data in the application form, he can not become a member of the RA and consequently of the AMF ČR / BSMK.

He/she agrees that, on the basis of Article 6 (1), letter a) The Regulation the Administrator processed his/her 1. photos, 2. videos, 3. audio recordings, 4. sports results for a purpose of:

- marketing (especially in promotional materials, flyers),
- web presentations,
- presentations on social networks (such as Facebook, Instagram, Twitter, etc.)
- presentations in the annual report and other information materials.

He/she further agrees that the Administrator will also process his or her:

1. telephone number, 2. e-mail, 3. birth number

for the purpose of keeping a membership base and related activities (such as applications for subsidies, handling of insurance, etc.).

The member agrees that his or her Personal Data be processed and stored for the entire duration of the processing purpose (that is, even after he/she stops performing the activity for which he/she is registered by the Administrator).

He/she understands his or her rights to:

- have access to their Personal Data (pursuant to Article 15 of the Regulation);
- request their correction (under Article 16 of the Regulation),
- the deletion of personal data without undue delay, if there are reasons under Article 17 of the Regulation,
- to limit the processing of personal data in cases under Article 18 of the Regulation,
- the portability of data in the cases provided for in Article 20 of the Regulation,
- revoke this Consent pursuant to Article 7 (3) of the Regulation,
- file a complaint against the Data Administrator pursuant to Article 77 of the Regulation.
